In the early 2000s, as a means of taking her practice to a higher level, the veteran Boston area attorney launched her new website www.seriouslaw.com and created the powerful slogan "Serious Lawyers for Serious People."

Her branding concept had evolved, but in truth, Shenia had been a successful, no nonsense general practitioner for many years. After majoring in her first love, Criminal Justice at Northeastern University, she achieved the highest grade in her first year Property Law class at Suffolk University Law School, resulting in her earning the AMJUR, the American Jurisprudence Award. She launched her career as an attorney with a firm that covered everything from real estate and divorce to high profile murder cases.

When she started her own practice in 1991, Shenia continued in that vein, developing a thriving firm with multiple associates whose wide range of legal services included Family Law, Probate Law, Administrative Law, Real Estate law, Civil Litigation, Business Law, Personal Injury Law and Criminal Law.

From 1989-94, while growing her practice, the Mississippi born, Boston raised attorney also taught COLLEGE night classes in Constitutional Law, Criminal Law and Evidence and Courtroom Procedure. She later presented for several years at Family Law seminars for Massachusetts Continuing Legal Education (MCLE). In addition to being a Real Estate Title Agent, a Real Estate Broker and Notary Public, she has served as a Commissioner to sell real estate and as a Guardian ad Litem, advocating for children and the elderly in the Probate and Superior Courts. Her other accolades have included two time winner of the Outstanding Young Women of America Award.

Shenia has a special expertise in family and probate law.
